Health, Safety & Environmental Policy Statement

- A systematic approach will be used to identify hazards and allocate resources or measures to control them;
- Plant, equipment and systems of work that are safe and without risks to health will be provided and maintained;
- Provisions will be made for ensuring safety and the absence of risks to health in connection with the use, handling, storage and transport of articles and substances;
- Carry out reasonable audits and inspections, at the frequency suitable for the project in hand, as deemed by Management;
- Risks associated with all work activities will be eliminated, where possible, or minimised;
- Occupational health advice and facilities will be provided where appropriate;
- Satisfactory measures for the participation of employees in the development of measures for promoting health, safety and welfare at work will be maintained;
- All Employees and sub-contractors will be motivated and empowered to work safely.

In recognition of construction and its potential impact on the environment; ACBS Ltd. is committed and has a duty to protect the environment, which is proactively demonstrated through this policy.

ACBS Ltd. will meet or improve upon legislative and regulatory environmental requirements and codes of practise; with an aim to contain the environmental impact of our activities to a practicable minimum, in accordance with environmental ideologies.

- ACBS Ltd. will continue to develop and refine environmental management systems, aiming to continuously improve upon our environmental performance;
- Continue to promote the purchase and use of materials that minimises potential adverse environmental effects;
- Consider waste minimisation initiatives to recycle, reuse and reduce waste across the business and our projects;
- High level of vigilance over our projects and careful planning, to ensure that damage to the environment is eliminated or minimised.
- Develop and implement regular environmental audits of our activities and facilities,
 implementing recommendations as required;
- Use local suppliers as much as possible to minimise transport requirements and support the local economy;
- All employee and sub-contractors are asked to act in an environmentally conscious manner and be aware of ACBS Ltd.'s responsibilities towards the environment.
